


UW-MADISON ACADEMIC STAFF FACTS

BY THE NUMBERS

Over 10,000 academic staff at UW-Madison comprise the largest employee group on campus. Below is the composition of the academic staff from Fall 2020.



CONTRIBUTIONS TO THE UNIVERSITY

Teaching

30% of course sections offered on campus were taught by academic staff from Fall 2020.

Research

Over \$197 million (12%) in grants awarded to academic staff Principal Investigators in 2020-21.
Over \$360 million (22%) awarded in grants to academic staff Principal Investigators, co-Principal Investigators, or co-Investigators in 2020-21.

Outreach

Academic staff play an important part in the *Wisconsin Idea*, leading much of the outreach on campus. Several leading outreach efforts, including the *Community Partnerships & Outreach* network and the *Science Alliance*, are led by academic staff.

Student Services

Academic staff play a key role in every part of a student's career, including but not limited to admissions, teaching, advising, library services, registrar's office, bursar's office, financial aid, student life, diversity programs, student support programs, health services, housing, recreation, athletics, etc.

Academic Staff Assembly

The Academic Staff Assembly is an elected body of currently 119 districts that represents the interests of academic staff in governance and policy development at UW-Madison. The Assembly debates and votes on policy issues affecting academic staff presented by the Academic Staff Executive Committee (ASEC), members of Assembly standing committees, or the Assembly.

Each district is grouped first by job codes (titles) and then by division and department. Representatives are elected for two-year terms; there is no limit on the number of terms they can serve.
